- 2) Drain filtration, heating and plumbing
- 3) Blow out filtration lines, equipment and install plugs (winter plugs not included in price.)
- 4) Remove automatic vacuum and store on owner's property
- 5) Install freeze protection container in skimmer
- 6) Vacuum and skim surface of pool
- 7) Add winter chemical package (chemicals not included in price)
- 8) Blow off pool deck area
- 9) Remove and clean filter media
